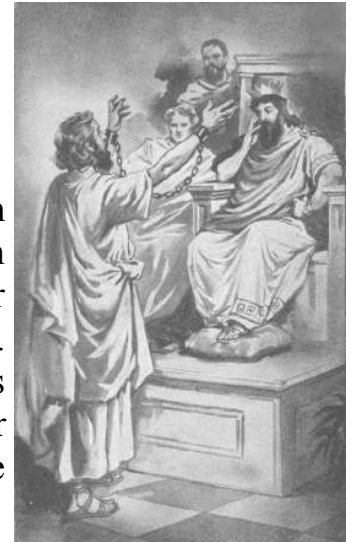

## Agrippa's Confrontation with the Gospel

We wonder what it was that made the apostle Paul so ineffective with teaching Agrippa the gospel. Agrippa was the king over a small section of Palestine. He had journeyed to Caesarea to extend welcome, or "salute" Festus who had recently replaced Felix as the Roman governor. Agrippa knew the Jewish customs and laws. He wanted to hear Paul's case when told by Festus (Acts 25:13-22). Festus arranged a hearing for Paul and Agrippa. Had he not appealed, he could have been set free (Acts 26:32).



Paul began by expressing his gratitude for being allowed to come before someone knowledgeable of the Jewish customs and laws (Acts 26:2-3). He made his defense and stated that he had lived openly before his brethren. He was not only a Jew, but of the strictest sect, a Pharisee. His kinsmen could bear witness to his loyalty to the law and customs of the Jews. Paul was being charged for believing in the promises made by God to Israel (v. 6). He believed the same things of his forefathers; if guilty, his Jewish ancestry was guilty because they had longed for the Messiah, but not ready to accept Him yet. The Pharisees rejected the idea that Jesus was the long awaited Messiah. The Sadducees rejected His teaching of the resurrection (Acts 23:6; 24:21). He had been a former persecutor of believers (Acts 26:8-12), but became converted (26:12-19). Festus accused him of being mad, so Paul appealed to Agrippa (26:27-29). Paul almost persuaded him to become a Christian.

Agrippa's refusal to obey was not the fault of Paul or the message. Paul was direct with him, "why Agrippa?" He had heard eye-witnesses of the resurrection of Jesus testify, but still rejected the word as men do today (Rom. 1:16; 10:17; Jas. 1:21). The seed in Agrippa's case had fallen by the wayside and never, to our knowledge, took root (Mk. 4:10-15). The outcome remains the same today as then, anyone who rejects Jesus, whether king or commoner, is lost (Jn. 8:24)!

We conjecture that Agrippa may have been lost because of his neglect in obeying what he had learned to be truth. The gospel is mighty and powerful, but limited in its influence when thwarted by the hardness of a human heart. God could overpower man's desire, control his emotions and force obedience to Him. This would be intrusive of God and manipulative to man. God wants us to want Him and be drawn to Him out of our deep love, respect, and desire to please Him.
